- Any merchandise/products that need to be brought in after these dates must be brought in from the parking lot.

## **Dismantle Time:**

Saturday after the exhibition building closes at 10:00 pm -11:30 pm and Sunday 10am-12pm. Vehicles are only allowed on fair property after fair gates have closed. <u>Driving into fairgrounds to load out on Saturday evening is not guaranteed.</u>

Times vendor booths will be open: Wednesday, August 11th through Friday August 13th, 4pm-10pm Saturday, August 14, 10am-10pm Indoor Booths: Electricity Y N Reserve\_\_\_\_\_\_ booth(s) inside the exhibition building for our Commercial exhibit at the cost of \$200.00 per exhibit space (10'x10') or two spaces (10' x 20') for \$375.00. Space is limited. (Outdoor spaces are available, table & chairs provided. Tents will not provided & electricity is limited) \*Early registration \$180.00 (10'x10') or \$337.00 (10'x20') before June 1, 2021. Outdoor Booths: Electricity Y N (limited spaces with electricity outside) Reserve square feet of exhibit space for an outdoor exhibit at the cost of \$.25 per square foot. Minimum cost \$150.00. (20'x30') \*10% off registered before June 1, 2021. Passes: 8 one day passes are included with your registration. ## **Rules & Regulations:**

- These booths are for manufacturers, businesses, retailers, and individuals who market a product and/or service. An opportunity for public exposure and awareness is made possible through these rented spaces.
- 2. The vendor agrees to provide manpower to operate the booth according for the following schedule:

Wednesday, August 11th 4pm-10pm Thursday, August 12th, 4pm-10pm Friday, August 13th, 4pm-10pm Saturday, August 14, 10am-10pm

- 3. Booths will remain open until the building closes during the fair. Failure to comply may jeopardize future contracts with your business or organization.
- 4. One space per company, all spaces are first come, first serve.
- 5. A picture of the booth should be included with registration.
- 6. Early registrations before June 1, 2021 will receive 10% off the registration fee.
- 7. Registrations received after August 1, 2021 will be charged a \$25 late fee.
- 8. Payment can be made with cash, check, or money order. No credit/debit payments can be accepted.
- 9. Refund requests may be made in writing before July 1, 2021. No refunds will be granted after July 1, 2021.
- 10. Each booth will be provided **one** vehicle pass allowing one vehicle to park at the fairgrounds in the designated parking lot. No vendors will be able to park inside the fairgrounds.
- 11. One table and two chairs will be provided.
- 12. The Franklin Southampton County Fair will exercise all reasonable diligence in protecting the property of exhibitors, but will not be responsible for property lost due to theft, fire, robbery, accident or any other destructive cause, or for any injury that may arise to the public in the leased area or to Exhibitors and/or their employees while on the Fairgrounds.
- 13. Due to the developing Covid-19 pandemic, indoor vendor spaces may be moved outside to abide by state and local guidelines. If the board of directors determines that the event must be cancelled due to the Covid 19 pandemic refunds will be issued.
